Announcement for Removal of Obsolete Mobility Access Switch Regulatory Part Numbers

Confidentiality Level: Public

Aruba Networks is consolidating Mobility Access Switches part numbers by removing those with US and IL (Israel) regulatory suffixes.

Note this is not an end-of-sale of any Mobility Access Switch platform, only the deletion of regulatory suffixes from the Aruba price list and ordering systems. The regulatory codes for Mobility Access Switch have no impact on the functionality of the Mobility Switch platform.

All Mobility Access Switches will remain orderable and fully supported by ArubaOs 7.x.

As of February 1, 2014, all Aruba mobility Access Switches will use only the unregulated part number.

In the table below, the “Direct Replacement” product listed in the table below is IDENTICAL to the “Obsolete” part number.
